New member appointed to Executive Board

Bernhard Bringmann will head Business Unit 1 as of 1 January 2014. He will succeed Walter Börsch, who, as announced earlier, will assume the position of CEO of Starrag Group as of the date of the 2014 Annual General Meeting.

Bernhard Bringmann (35, German) joined Starrag in 2008 as Head Test Field in Rorschacherberg. He occupied different positions, from 2009 Deputy Head of Development, from 2010 Innovation Manager for Starrag Group, and since the beginning of 2012 Head of Engineering at Starrag Rorschacherberg.

Bernhard Bringmann studied mechanical engineering at the Technische Universität München, the Rensselaer Polytechnic Institute in Troy/USA (Master of Science in Mechanical Engineering) and at the Institute of Machine Tools and Manufacturing, ETH Zurich (Dr. sc. ETH). Prior to joining Starrag Group, Bringmann had worked at the aforementioned ETH institute as a scientific assistant since 2003. As Head of Business Unit 1 he will be responsible for the Starrag brand (Rorschacherberg/Switzerland) and the TTL subsidiary (Haddenham/UK). Bringmann is Fellow Member of the International Academy of Production Engineering CIRP.
